

**FACTSHEET ON STREAMLINED PROCESSES AND REDUCED COMPLIANCE COST FOR TRAINING PROVIDERS**

**Background**

Training providers will enjoy reduced compliance cost and streamlined processes, which take effect 1 July 2019. The following tables show a comparison of the different fees and processes before and after the change for Private Education Institutions (PEIs), WSQ training providers and non-WSQ training providers.
